



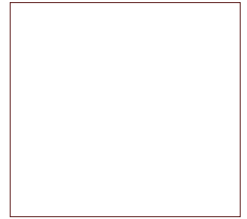

## **RULES & REGULATIONS**

1. Registration Fees Rs. 500/- (Rupees Five Hundred) only.
2. Yearly Membership Fees Rs. 600/- (Rupees Six Hundred only) and it must be given on the date of joining. (Bank Draft/Cheque will also be accepted). New Membership will be taken from 1<sup>st</sup> April to 15 May in every year.
3. Renewal of Membership will have to be done at the end of every year.
4. Life-Time Membership Fees Rs. 10,000/- (Rupees Ten Thousand) only. (Bank Draft/Cheque will also be accepted)
5. Every Member, as a matter of Principal, is expected to co-operate with and participate in all the activities of the Organisation.
6. Members are required to be present in the Annual General Meeting of the Organisation.
7. Membership for the first three years will be treated as “Honorary Membership”.
8. On the basis of regular participation and active co-operation an Honorary Member may be elevated to the position of the “General Membership”.
9. Only the General Members are competent to take part in the deliberations of adopting resolutions or in the formation of Executive Body.
10. The Executive Committee is the only body which will select the participants in different functions of the Organisation.
11. The Members will have to bear the conveyance expenditure if any, during their participation in the organizational functions and activities.
12. The Members must maintain the dignity of the Organisation to uphold the lofty ideas thereof.
13. If anybody acts against the rules of the organization then his or her membership will be discontinued.
